1. This form will be displayed on all media platforms of ZIMU for access or email UAEC for immediate access.
2. You are required to download it, print and fill it in upper case letters. (Capital letters)
3. Attach a colored passport photo at the top right of form (the one to also be considered on the election ballot paper)
4. You are reminded to read instructions and submit or attach all the required supporting documents therein i.e.;
 - A copy of a valid national ID or Birth certificate as proof of age and nationality.
 - Take note to obtain a ZIMU Membership no. as its proof to be a member of ZIMU.
 - A certified copy of a letter of endorsement by the candidate's affiliation.
5. On payment of agreed non-refundable nomination fee of UGX 200,000 on the ZIMU Account **A/C 1014201413152**, attach the receipt copy and required documents thereby submit through the chairperson AEC on email or WhatsApp to book an appointment on returning nomination form.
6. All fields are **compulsory** and improper filling of the form leads to termination of nomination and any related crimes/ offence will be dealt with as required by the law.
